


Fig.1 Forward Current Derating Curve




Fig.2 Typical Junction Capacitance




Fig.3 Typical Reverse Characteristics




Fig.4 Typical Forward Characteristics




Fig.5 Typical Reverse recovery time versus di/dt





Fig.6 Typical Reverse recovery charges versus di/dt






